Average fee ranges

At the beginning of the matter, we will provide an estimate of our likely charges however as there are so many variables in a matter such as this it may become necessary to revise our estimate. Any estimate revision will be fully discussed with you before any additional work is undertaken.

What does my fee include?

Your fee will include the following advice and assistance:

- Consideration of documents provided
- Attendances and communication with you to establish the facts of your matter and obtaining further information from you where necessary
- Expert advice on the relevant process and law in respect of your matter
- Preparing and submitting your application
- Drafting a detailed covering letter with reference to the relevant law setting out how the facts of your application meet the relevant requirements

Timescale
